The cost to repair any damage to DSA property will be recovered from the hirer/ hiring organisation. The hirer(s) shall have in place a current and effective insurance which indemnifies DSA against all eventualities and any and all liabilities arising from the hirer's use and activities on the range complex. Such insurance to be exhibited to the Range Manager before the range booking(s) can be confirmed.

CONDITIONS OF HIRE

1. Hirer(s) are to provide their own targetry.
2. Hirer(s) shall provide sufficient trained, qualified and competent Range Officers for the safe supervision of the types of shooting practice to be carried out.
3. Hirer(s) confirm they have accessed, read and will fully comply with DSA Range Orders (<https://www.duchyshooting.co.uk/downloads-and-info.html>) applicable to the range hired.
4. Hirer(s) shall ensure anyone using home or hand-loaded ammunition completes the DSA Home-loaded Ammunition Declaration and hands it to the Range Manager before firing practice commences.
5. Hirers are to leave the range in a clean and tidy condition.
6. The hire does not include use of the DSA clubhouse (except for toilets).
7. If hired for use by black powder/muzzle loading firearms, no cartridge or breech-loaded ammunition may be fired during the period of the hire.
8. Range flags are to be posted in accordance with Range Orders.
9. First round down the range not before 0900; last round not after 1600.

EXTRACT FROM THE CONSTITUTION OF DUCHY SHOOTING ASSOCIATION

(14) USE OF RANGE BY OTHER CLUBS

(a) The Range Committee may let the range for use by other clubs whose activities do not compete with our own Association activities and on such terms as they shall decide.

(b) Such lettings shall be on two scales or rates:

(i) Other shooting clubs or associations which are not for profit organisations and do not charge for participation (except membership)

(ii) Commercial organisations which charge for participation in their services/courses.

(c) Such scales or rates are to be made up of two elements:

(i) A 'Facilities Charge' which covers the hire of the range and range premises, including the obligatory attendance of the key holder.

(ii) A 'per capita' charge for all participants in the event, including instructors or supervisors.

(d) Any organisation hiring all or any part of the Association range complex shall have in place a current and effective insurance which indemnifies the Association against all eventualities and any and all liabilities arising from the hirer's use and activities on the range complex. Such insurance to be exhibited to the Range Manager before the range booking(s) can be confirmed.
